

Special Meeting - September 30, 2008

The Board of Trustees of the Village of Tularosa met in a Special Meeting on Tuesday, September 30, 2008 at 7:00 P.M. in the Court/Conference Room of the Public Safety Facility located at 609 St. Francis Drive, Tularosa, New Mexico.

Non-certified Patrol/Entry Level \$8.00 - \$10.00

Certified Patrol/Non-New Mexico Certified (currently certified in another state *with proof*) \$10.00 - \$12.50

Non-Certified Dispatchers/Entry Level \$7.00 - \$9.00 **Certified Dispatchers-Lead Dispatcher NCIC/TAC Qualified** \$10.00 - \$16.00

Dispatcher/Certified \$9.00 - \$12.00

Animal Control Officer \$8.00 - \$12.00
